2. Does your work primarily serve the 21-county Metro Atlanta region or have statewide impact?
3. Does your organization focus on improving access to education or mental health for children, youth, or families?
4. Does your work strengthen systems or infrastructure (e.g., workforce development, policy or advocacy, coordination, navigation, shared pathways)?
5. Is your organization rooted in, accountable to, or meaningfully guided by the communities most affected by inequities in education or mental health access?
